Proposal for Outsourcing of to the O/o....., as per circular Memo No.11606-B/419/A2/SMPC/2009, Dt.24-04-2009.

S.No	Quest of the Question	Answer
1.	Category & No of posts to be outsourced/Contract appointment should be indicated.	
2.	Whether the proposed posts for outsourcing is against the vacant posts in the sanctioned cadre strength or over and above the sanctioned strength.	
3.	Original cadre strength of the category which is proposed to be outsourced (as per the implementation committee G.Os) has to be indicated along with the G.O.No. in which these posts were continued.	
4.	No of persons presently working on regular/contract/outsourcing basis in the category.	
5.	No of posts vacant and date from which these posts are vacant.	
6.	Scale of pay of the category for which the department has proposed for Contract / Outsourcing appointment.	
7.	Proposed Remuneration has to be mentioned for the Category to be appointed on contract /Outsourcing basis keeping in view of the minimum time scale.	
8.	Financial implications involved in the proposal	
9.	Budget particulars	
10.	Feasibility of Outsourcing the activity like Sweeping /Security etc. instead of appointment of individuals on Outsourcing.	
11.	Proposals for Sweeping and Security activities should be examined keeping in view of the all offices located in an office complex and also the availability of manpower in all offices.
