The final seniority list of Assistant Engineers of Direct Recruitment / Appointment by transfer from 1990 to 2011 was communicated vide this office Circular Memo. reference 1st cited, duly placing on the website, by disposing of objections received on the provisional seniority list.

It is informed that the Hon'ble Supreme Court of India pronounced the judgement vide reference 2nd cited with regard to Rule-16(h) of State & Subordinates.

Based on the above orders of the Hon'ble Supreme Court of India, the seniority list of the Assistant Engineers who passed the Account Test belatedly and effected by Rule-16(h) has to be restored to their original seniority at appropriate place based on their appointment. Hence, the seniority list of Assistant Engineers published earlier vide reference 1st cited is reviewed now in accordance with the judgement 2nd cited, duly restoring the seniority of the candidates effected by Rule-16(h) in the cadre of Assistant Engineers by placing them at appropriate place.

The names of the Assistant Engineer, who were appointed by transfer from the cadre T.A's/JTO's/ATO's and W.I during the period from 2012 to 2015 are also placed in the seniority list of AE's at appropriate place.

Thus the provisional seniority list of Assistant Engineer of Direct Recruitment / Appointment by transfer during the period 1990-2015 is prepared and is here with communicated to all the concerned. The Seniority list is available on the website www.irrigation.telangana.gov.in.

As per the State & Subordinate Service Rules, 1996, the effected persons shall be given an opportunity of making representation against the proposed revision, before any order of revision is passed.

In view of the above, all the Assistant Engineers mentioned in the list are requested to submit their objections if any, regarding correction of Name, Date of Birth, Date of Joining and date of regularization of service or their position in provisional seniority list etc., on or before **05-07-2019** directly to this office or through email ID encawasec@gmail.com.

In case, no objections are received within the stipulated time, it shall be construed that there are no objections and the seniority list will be finalized, subject to outcome of all related court cases, if any. No separate seniority list will be communicated individually.
