Sub:- I & CADD., - Certain relaxations / Concessions in respect of reservation of works to SC/ST Contractors in Public works – Orders – **Clarification for exemption of Solvency certificate for Registration of Contractors in Class-III & Class-IV (Civil category) to Waddera/Sagara communities in terms of G.O.Ms.No.59 – Requested -Regarding.**

The Superintending Engineer, Irrigation Circle, Ranga Reddy vide letter 2nd cited has requested to issue clarification in respect of exemption of Solvency certificate for Registration of Class-III and Class-IV contractors to the Waddera / Sagara community societies and individuals.

Further, the President, Renuka Waddera Sand Quarry and Stone Cutters Labour (Co-operative Society) vide letter 3rd cited has made similar request in the subject matter.

In this regard, it is to inform that under Para- 8, Page No-3 of G.O Ms No 59, I&CAD., (Reforms) Dept., Dt: 21.05.2018 the following is stipulated.

“Government also consider the recommendation of the Board of Chief Engineers (BOCE’s) and Engineers-in-Chiefs (ENC’s) Committee to reserve 3% of works exclusively to Waddera/Sagara communities in addition to SC/ST quota, with relaxations/Concessions on par with SC/ST Communities”.

As per above Para-8 of GO 1st cited, *it is clarified that the relaxations/Concessions extended to SC/ST communities in the G.O Ms No 59, I&CAD., (Reforms) Dept., Dt: 21.05.2018 towards Solvency, EMD etc., will be*

equally applicable to Waddera/Sagara communities for their allotted quota of 3% of works reserved to them.

Therefore, all the ENCs and CEs of I&CAD Dept., are requested to take necessary action in the matter, accordingly.
