In response to this office circular memo 2nd cited, the circle / unit officers have furnished proposals for including the Physical Handicapped status against the names of AEEs & AEs who are having physical disabilities (VH/OH/PH) as per the certificates furnished by the concerned Medical Boards.

As per the proposals submitted by the circle / unit officers, the matter has been examined and the AEEs / A.Es (as per the annexures) who comes to the extent of coverage in terms of Para 3 of GOMs. No. 31 dt: 01.12.2009 are eligible to claim the disability under Physically Handicapped Quota and necessary entry of Physical Handicapped Status is being entered in the seniority list against their names, subject to the following conditions:


1. The orders now issued is subject to the verification of genuineness of the certificate from the concerned medical board in due course.
2. If the certificate produced found to be false / fake at a later stage, necessary severe disciplinary action will be initiated against them including criminal case.
