- Assistant Engineer/Assistant Technical officer/Junior Technical Officer and Technical Assistant and Work Inspectors of all grades who possess a Bachelor's degree in **Civil & Mechanical Engineering** of a University in India established or incorporated by or under a Central Act, Provincial Act or a State Act or an Institution Recognized by the University Grants Commission/All India Council for Technical Education or an Equivalent qualification with three years of service be considered for appointment by transfer to the post of Assistant Executive Engineer and it is pre-requisite, that they shall pass the Accounts test for PWD officers and Sub-ordinates.

Documents required:

- a) All original study certificates.
- b) Genuiness of Bachelor's Degree submitted by the applicant after ascertaining the confirmation from the concerned Universities.
- c) Annual Confidential Reports / Appraisal reports for the last 3 years.
- d) Filled-in Proforma (all service details with counter signature of circle / unit officer)
- e) Service Book with updated entries.
- f) No charges pending certificate.
- g) Permission letter for perusing higher studies ie., B.E., / B.Tech. from the department.

Further, it is also requested to furnish the updated C.Rs and no charge certificate of the individuals listed in the statement.

All the Superintending Engineers and Chief Engineers are requested to furnish the above particulars along with the filled-in prescribed proforma and documents to this office on or before **03-04-2017**, duly deputing the concerned Superintendent of the office, failing which it will be construed that there is no information to be furnished and the unit / circle officers will be held responsible for any further claims by the individuals.
