Government have taken up a Programme "Mission Kakatiya" as a part of restoration of Minor Irrigation Tanks in Telangana. The programme is proposed to be completed in a phased manner in 5 years period. Out of 46531 tanks available in Telangana, about 9306 tanks are proposed to be taken up in first phase during this year.

The Government vide reference 1<sup>st</sup> cited have accorded permission to engage the Services of 115 Retired Deputy Executive Engineers/ Assistant Executive Engineers/Assistant Engineers/Technical Officers for a period of One year to meet the work load of Minor and Medium Irrigation works, subject to the following conditions.

- iii) The retired Engineers who have not crossed the age of (65) years shall only be considered as the retired Engineers have to work mostly in the field level for restoration of Tank works.

The Chief Engineer, Minor Irrigation vide reference 4th cited has submitted the proposals of **Sri B.Satyam**, AE(R) in place of Sri Mohd. Shareef, AE(R) for engaging the Services on contract basis for a period of one year.

After examining the proposals of the Chief engineer, Minor Irrigation, Orders are hereby issued engaging the services of **Sri B.Satvam**. AE(R) for the period of one year from the date of this proceeding.

The Orders issued in engaging the services of Sri Mohd. Shareef, AE(R) are hereby cancelled with immediate effect.
