The Committee of Engineers-in-Chief and the Commissioner, Commissionerate of Tenders have examined the application received from M/s.Piyush Infratech Pvt.Ltd (CIN: U45400MH2013 PTC244147) referred to for Registration as Special Class Contractor in terms of Government orders cited at its 51<sup>st</sup> meeting held on 26-08-2016 and approved for registration as Special Class Contractor in the category of "Civil " .

1. Based on the decision of Committee of Engineers-in-Chief and the Commissioner, C.O.T,M/s.Piyush Infratech Pvt.Ltd (CIN: U45400MH2013 PTC244147) is registered as Special Class Contractor in the category of "Civil" with registration No.**COT/TS/SP/429/2016** to tender for works in all the Engineering Departments of the State Government.
- 2.The Special Class Contractor registered under the category of "Civil" is qualified to tender for works costing up to any amount.
- 3.The Managing Director/ Director of the Company, which are now registered as Special Class Contractor, shall intimate the changes in the Directors of the company, if any , to the registering authority immediately, duly furnishing an affidavit on Rs.100/- Non Judicial stamp paper stating that the incoming Director/Directors declare that, they do not have any other Contractor Registration either individual or a partner in a Firm or a Director in a company. Failure to notify the changes to the registering authority within one month of such change will entail the Company to forfeit registration and further the company will be debarred from tendering for works.
4. The Registration is valid up to 5 years from the date of Registration. The Registering authority reserves the right to cancel or demote without any notice and without assigning any reasons.
