The Committee of Engineers-in-Chief and the Commissioner, Commissionerate of Tenders have examined the application received from Sri.S.Saibabu , S/o.Sri.Satyanarayana, referred to for registration as Special Class Contractor in terms of Government orders cited at its 65<sup>th</sup> meeting held on 14-06-2017 and approved for registration as Special Class Contractor in the category of "Civil "

1. Based on the decision of Committee of Engineers-in-Chief and the Commissioner, COT, the registration of Sri.S.Saibabu , S/o.Sri.Satyanarayana, is Registered as Special Class Contractor in the category of "Civil" with registration No.COT/TS/SP/545/2017 to tender for works in all the Engineering Departments of the State Government.
2. The Special Class Contractor registered under the category of "Civil" is qualified to tender for works costing up to any amount.
