Ahmed Bin Abdulla, Individual Contractor, referred for renewal of registration as Special Class Contractor in terms of Government orders cited at its 70th meeting held on 16-09-2017 and approved for registration as Special Class Contractor in the category of "Civil "

1. Based on the decision of Committee of Engineers-in-Chief and the Commissioner, COT, the registration of Sri Abdulla, S/o Sri. Ahmed Bin Abdulla, Individual Contractor, is Registered as Special Class Contractor in the category of "Civil" with registration No.COT/TS/SP/575/2017 to tender for works in all the Engineering Departments of the State Government.
- 2.The Special Class Contractor registered under the category of "Civil" is qualified to tender for works costing up to any amount.
3. The Registration is valid up to 5 years from the subsequent date of the expiry of previous registration date i.e from 18-04-2017 to 17-04-2022. The Registering authority reserves the right to cancel or demote without any notice and without assigning any reasons.
4. Application for renewal of Registration beyond 17-04-2022, if desired, should be submitted to this office before one month from the date of expiry of validity of registration.
5. All the existing registrations under this category stand cancelled.
