The Committee of Engineers-in-Chief and the Commissioner, Commissionerate of Tenders have examined the application received from M/s. G Infra Projects Limited (CIN: U45400TG2015PLC102010) referred to for Registration as Special Class Contractor in terms of Government orders cited at its 71st meeting held on 17.10.2017 and approved for registration as Special Class Contractor in the category of "Civil".

1. Based on the decision of Committee of Engineers-in-Chief and the Commissioner, C.O.T, M/s. G Infra Projects Limited (CIN: U45400TG2015PLC102010) is registered as Special Class Contractor in the category of "Civil" with registration No. **COT/TS/SP/584/2017** to tender for works in all the Engineering Departments of the State Government.
2. The Special Class Contractor registered under the category of "Civil" is qualified to tender for works costing up to any amount.
3. The Managing Director/ Director of the Company, which are now registered as Special Class Contractor, shall intimate the changes in the Directors of the company, if any, to the registering authority immediately, duly furnishing an affidavit on Rs.100/- Non Judicial stamp paper stating that the incoming Director/Directors declare that, they do not have any other Contractor Registration either individual or a partner in a Firm or a Director in a company. Self-declaration /Affidavit stating that they have not been blacklisted, declaration that they do not have any cases pending against them. The Original Proceeding issued will holds good for its Validity period. Failure to notify the changes to the registering authority within one month of such changes will entail the Company to forfeit the registration and further the company will be debarred from tendering for works.
4. The Registration is valid up to 5 years from the date of Registration. The Registering authority reserves the right to cancel or demote without any notice and without assigning any reasons.
5. All the assets and liabilities including obligations and the ongoing works entrusted in the name of M/s G.K.Contractors & Suppliers and to receive all the bills pending from various departments along with the experience gained shall stand transferred into the name of company M/s G.Infra Projects Limited.
