The Committee of Engineers-in-Chief and the Commissioner, Commissionerate of Tenders have examined the application received from M/s.H.K Constructions (Firm No.184 of 2008) , referred to for Registration as Special Class Contractor in terms of Government orders cited, at its 72nd meeting held on 07.11.2017 and approved for registration as Special Class Contractor in the category of "Civil "

1. Based on the decision of Committee of Engineers-in-Chief and the Commissioner, C.O.T, M/s.H.K Constructions (Firm No.184 of 2008) is registered as Special Class Contractor in the category of "Civil" with registration No. **COT/TS/SP/596/2017** to tender for works in all the Engineering Departments of the State Government.
2. The Special Class Contractor registered under the category of "Civil" is qualified to tender for works costing up to any amount.
3. The Managing Partner/ Partners of the firm, which are now registered as Special Class Contractor, shall intimate the changes in the Partnership deed, if any and produce fresh solvency certificate in the name of the firm M/s.H.K Constructions (Firm No.184 of 2008) with substituting Partners along with revised Partnership deed and Form-A issued by Registrar of Firms. Failure to notify the changes to the registering authority within one month of such change will entail the Firm to forfeit registration and further the firm will be debarred from tendering for works.
4. The Registration is valid up to 5 years from the date of Registration. The Registering authority reserves the right to cancel or demote without any notice and without assigning any reasons.
