The Committee of Engineers-in-Chief and the Commissioner, Commissionerate of Tenders have examined the application received from M/s GHK Infra Projects Private Limited (CIN: U45101TG2017PTC120034) (formerly M/s GHK Projects , Prop G.Harikrishna) referred to for Registration as Special Class Contractor in terms of Government orders cited, at its 75<sup>th</sup> meeting held on 03.01.2018 and approved for registration as Special Class Contractor in the category of "Civil " .

1. Based on the decision of Committee of Engineers-in-Chief and the Commissioner, C.O.T, M/s GHK Infra Projects Private Limited (CIN: U45101TG2017PTC120034) (formerly M/s GHK Projects , Prop G.Harikrishna) is registered as Special Class Contractor in the category of "Civil" with registration No. **COT/TS/SP/616/2018** to tender for works in all the Engineering Departments of the State Government.
2. The Special Class Contractor registered under the category of "Civil" is qualified to tender for works costing up to any amount.
3. The Managing Director/ Directors of the Company, which is now registered as Special Class Contractor, shall intimate the changes in the Directors of the company, if any, to the registering authority immediately, duly furnishing an affidavit on Rs.100/- Non Judicial stamp paper stating that the incoming Director/Directors declare that, they do not have any other Contractor Registration either individual or a partner in a Firm or a Director in a company, Self-declaration /Affidavit stating that they have not been blacklisted and declaration that they do not have any cases pending against them. The Original Proceeding issued will holds good for its Validity period. Failure to notify the changes to the registering authority within one month of such changes will entail the Company to forfeit the registration and further the company will be debarred from tendering for works.
4. The Registration is valid up to 5 years from the date of Registration. The Registering authority reserves the right to cancel or demote without any notice and without assigning any reasons.
5. Application for renewal of Registration beyond 5 years, if desired, should be submitted to this office before one month from the date of expiry of validity of registration.
6. All the existing registrations under this category stands cancelled including the existing registration proceedings of Class-III in the category of "Civil" issued by the Superintending Engineer, (R&B) Circle, Karimnagar in the name of M/s GHK Projects, Prop G.Harikrishna
