The Committee of Engineers-in-Chief and the Commissioner, Commissionerate of Tenders have examined the application received from Sri Madadi Venkata Shyam Sunder Reddy, S/o.Laxma Reddy, Individual Contractor referred to for registration as Special Class Contractor in terms of Government orders cited at its 85th meeting held on Dt.20-07-2018 and approved for registration as Special Class Contractor in the category of "Civil"

1. Based on the decision of Committee of Engineers-in-Chief and the Commissioner, COT, Sri Madadi Venkata Shyam Sunder Reddy, S/o.Laxma Reddy, Individual Contractor is Registered as Special Class Contractor in the category of "Civil" with Registration No.COT/TS/SP/708/2018 to tender for works in all the Engineering Departments of the State Government.
2. The Special Class Contractor now registered under the category of "Civil" is qualified to tender for works costing up to any amount.
3. The Registration is valid up to 5 years from the date of Registration. The Registering authority reserves the right to cancel or demote without any notice and without assigning any reasons.
4. Application for renewal of Registration beyond 5 years, if desired, should be submitted to this office before one month from the date of expiry of the validity of registration.
5. All the existing registrations under this category stand cancelled.
