1. The Screening Committee constituted vide G.O. 1st cited have reviewed the panels of Assistant Executive Engineers/Assistant Engineers/ Draughtsman Grade.I/Spl.Grade for the period from 2009-2010 Panel to 2010-2011 Panel year and recommended the fit and eligible Assistant Executive Engineers/Assistant Engineers/Draughtsman Grade.I/Spl.Grade for promotion/appointment by transfer to the post of Deputy Executive Engineers duly verifying personal files of the individuals etc.,

Due to non receipt of confidential reports in respect of certain Assistant Executive Engineers / Assistant Engineers / Technical Officers from the concerned unit / circle offices, the Screening Committee deferred such candidates and recommended for promotion / appointment by transfer duly reserving vacancy subject to obtaining the Confidential Reports and to issue the orders.

The Confidential Reports in respect of the Assistant Executive Engineers / Assistant Engineer noted in the Annexure have been since received.

According under Rule 10 (a) of A.P. State and Subordinate Service Rules 1996, the Assistant Executive Engineer / Assistant Engineer / Technical Officers shown in the Annexure enclosed to the proceedings are temporarily promoted / appointed by transfer as Deputy Executive Engineers on notional basis, with effect from the dates mentioned against each in the respective panel year.

3. The promotions ordered above are subject to the directions/out come of OAs/WPs/WAs/RPs/CAs/SLPs etc., if any pending before the Hon'ble Courts.

4. They are also informed that, their promotion/appointment by transfer as Deputy Executive Engineer is purely temporary and subject to review/revisions/reversion at any time without notice and without assigning any reasons therefor. Their temporary

promotion/appointment by transfer as Deputy Executive Engineer does not confer on them any right what so ever for claiming regular promotion/appointment by transfer as Deputy Executive Engineer and it is also subject to review on the basis subject to the outcome of RPs/OAs/WPs/SLPs and appeals if any pending in the Tribunal/Courts.

5. As these Panels are now reviewed and regularized for the period from the dates mentioned against each retrospectively, the individuals are entitled to the seniority and regularization notionally from the dates mentioned against each. ***The effect of the promotion / appointment by transfer to the post of Deputy Executive Engineer will be prospective and the individuals are eligible for monetary benefit prospectively from the date of this proceedings as per Fundamental Rule-26 (aa).***

The Unit/Circle Officer concerned shall take necessary further action in the matter accordingly.
