1. In the G.O. 2<sup>nd</sup> cited, Government have accorded sanctioned for up gradation of one post of Superintendent to that of Non Technical Personal Assistant in (70) circle offices in I & CAD Deptt.. The Hon'ble APAT in its judgment vide reference 3<sup>rd</sup> cited, have clarified that the upgraded post of NTPA is a state wide post with Gazetted status and is to be filled up by following the State wide seniority of the Superintendents in I & CAD Department.

2. In the reference 5<sup>th</sup> cited, Government after careful examination of the matter ordered that the orders of the Hon'ble APAT, Hyderabad dated 13.12.2011 in O.A. No. 3535 of 2009 be implemented in their true spirit and the promotions be effected subject to the final outcome of the proposed inclusion of the Non Technical Personal Assistant post in the 3<sup>rd</sup> Schedule of the Presidential orders

3. In the reference 6<sup>th</sup> cited, as per the orders of the Hon'ble APAT and Government instructions Promotions issued to the post of Non Technical Personal Assistant with effect from 13.06.2008 on wards which were based on Zonal Seniority have to be reviewed as per the State Wide Seniority list now prepared and communicated.

4. The DPC constituted in G.O. 3<sup>rd</sup> cited have met on 13-10-2012 and recommended the eligible Superintendents for appointment by transfer as NTPA subject to revision and outcome of Court Cases if any. Accordingly the DPC have reviewed the promotions issued from the panel year 2007-08 to the panel year 2010-11 and approved the same. The DPC have also approved the present panel for 2012-13 for the existing vacancies.

5. Accordingly, under the powers delegated to the Heads of Departments in the G.O. 1<sup>st</sup> read above, and under Rule 10 (a) (i) of A.P. State and Subordinate Service Rules 1996 and subject to the conditions laid down in General Rule 10 (c) and (e) of AP State and Subordinate Service Rules of 1996 the Superintendents whose names are recommended by the Departmental Promotion Committee are appointed by transfer on temporary basis as Non Technical Personnel Assistant in the time scale of pay of Rs. 18,030 – 43,630/- and posted as Non Technical Personal Assistant to in the existing vacancies as per **ANNEXURE - A**.

6. ***The promotion ordered in Para 5 above is purely temporary and subject to reversion at any time without any notice and without assigning any reasons thereof and subject to outcome of final judgment if any. The promotions are also subject to the final outcome of the proposed inclusion of the Non Technical Personal Assistant post in the 3<sup>rd</sup> Schedule of the Presidential order.***

7. As per sub rule (b) of rule 11 of A.P.S & SS Rules, 1996 substituted in G.O.Ms.No. 145 GA (Ser.D) Dept, dt. 15-06-04 he shall join duty in the post of N.T.P.A, within **15 days** from the date of receipt of this order. If he fails to join duty in the new post of N.T.P.A within the stipulated period of **15 days** or evades to join duty in the new post by proceedings on leave, he shall forego the promotion right / offer for a period of 1 year and his name shall be considered for promotion again after a period of 1 year from the date of offer of the promotion, subject to availability of vacancy and eligibility.

8. As per Para 4 of Govt. Circular Memo 8<sup>th</sup> cited, in case the Superintendent refuses appointment by transfer as NTPA by not joining in the place posted, Automatic Advancement Scheme will not be made applicable to him in future.
