With reference to the subject cited, it is to inform that the Commission had decided to conduct the Departmental Examination in On-Line system with CBRT Method of Examination making modification to the pattern.

On request of the Government to examine the feasibility for adopting CBRT Method of examination for Departmental Test, the Commission vide Reference 1<sup>st</sup> cited, had submitted a report with certain proposals to the Chief Secretary to Government on switching over to CBRT method of examinations, which included the proposals for enhancement of Examination Fee, permission for allotment of exam centres other than the District of working place of the employees, and permission to extend the facility of paying T.A & D.A to the employees who will be allotted in other District centre to that of their working place. (for two attempts only). The permission is requested to extend such facility to the employees vide reference 5<sup>th</sup> & 6<sup>th</sup> read above.

Since the Commission already has a significant experience in conducting On-Line examinations, Government was communicated the decision of the Commission Vide reference 4<sup>th</sup> cited, to go ahead with CBRT method in place of Off-Line mode of pen & paper method from May – 2018 session onwards.

In the process of CBRT Examinations, Commission shall allot examination centres to the candidates in accordance with availability of systems of infra-structure in the District centers. Hence, examination centres will be allotted to employees who desire to apply for your departmental examination, in other than districts where they are working if sufficient systems of infra-structure in the District are not available.

Therefore, it is requested to make necessary arrangements for paying of T.A & D.A as per Rules in vogue to the employees to attend in other district centers for the compulsory Tests for two attempts only also sanctioning special leave following the Departmental Test Rules.

This is for information and further necessary steps to extend the facility to your Departmental employees.
