Sub: Estt: - TSES – Sri Peta Venkateswarlu, AEE - Representation addressed to the Government Directly without the Knowledge of his immediate Superior officer- Explanation called for – Reg.

Sri Peta Venkateswarlu, AEE working in Irrigation Sub Division No.4, Huzurnagar of Irrigation Division No.4, Kodad of I.C, Kodad has addressed the Principal Secretary to Government directly vide his representation 3rd cited duly making allegations that DPC members have not followed the rules and guidelines issued in the G.O. Ms. No. 32, I&CAD (Ser.I) Dept, dt: 25-4-2018 and considered promotions to the ineligible candidates as DEE vide Procs. no. RC/ENC/ B3/ 19121924/ 2020, dt: 30-1-2021.

Further, it is noticed that Sri Peta Venkateswarlu, AEE has addressed the Government directly vide his representation dt: 18-2-2021 without the knowledge of their immediate officers and made serious allegations on Departmental Promotion Committee.

In this regard, Sri Peta Venkateswarlu, AEE is informed that this office vide reference memo 1st cited has issued instructions to all the employees of the Department that “As per Para 86 of PWD code no officer should correspond direct with an authority superior to the officer under whom he is immediately serving, or which the state Government or to the Government of India, out of the regular course, except in case of extreme emergency, in which case he must send copies of his communication to his immediate superior together with a statement of his reasons for the direct correspondence”.

Further, vide reference memo 2nd cited instructions, were issued that no incumbent shall approach/represent to this office or any other authorities directly by way of making representations in their personal grievances/service matters and it should be made through proper channel from the Unit/Circle concerned, and any deviations in this instructions will be viewed seriously and necessary disciplinary action will be initiated against them as per rules in vogue. But Sri Peta Venkateswarlu, AEE has violated the above and addressed directly to the Government without the Knowledge of his immediate Superior officer and made serious false allegations on Departmental Promotion Committee, which attracts stringent disciplinary action.

In view of above, Sri Peta Venkateswarlu, AEE is hereby directed to submit explanation as to why disciplinary action shall not be initiated against him for addressing representation directly to the Government and also not following the instructions issued by the Head of the Department in the circular memos vide 1st & 2nd read above within 15 days of receipt of this order. If the explanation is not received within stipulated time, further disciplinary action will be initiated against him, as per TSCS (CC&A) Rules 1991.
