Sub: Elections – Model Code of Conduct – Biennial Election to the Telangana Legislative Council from 09 Local Authorities' Constituencies for 12 seats scheduled to be held on 10.12.2021 (Friday) - Applicability of Model Code of Conduct – Intimation – Reg.

Ref: ECI, New Delhi, Press Note No.ECI/PN/92/2021, dated 09.11.2021.

Copy of the reference cited, together with enclosures thereto, are communicated herewith to all the Departments of Telangana Secretariat, Hyderabad. They are informed that the Election Commission of India has announced Biennial Election to the Telangana Legislative Council from 09 Local Authorities' Constituencies for 12 seats of Telangana State, the notification of which will be published on 16.11.2021.

2. The Commission has stated that the Model Code of Conduct shall come into force with immediate effect in the District in which the concerned Constituency going for Biennial Election and the Model Code of Conduct shall be applicable to all Candidates, Political Parties and the State Governments concerned and further the Model Code of Conduct shall also be applicable to the Union Government in respect of Adilabad, Warangal, Nalgonda, Medak, Nizamabad, Khammam, Karimnagar, Mahabubnagar and Ranga Reddy districts of Telangana State. Hence the Model Code of Conduct has come into force in the entire districts mentioned above, with immediate effect i.e., from **09.11.2021**.

3. All Departments of Telangana Secretariat are, therefore, requested to intimate the same to all the Heads of Departments under their control for strict compliance of the Model Code with immediate effect and take necessary action accordingly.

4. They are further requested to instruct all the Heads of Departments and district officials of Adilabad, Warangal, Nalgonda, Medak, Nizamabad, Khammam, Karimnagar, Mahabubnagar and Ranga Reddy districts under their control not to address the Chief Electoral Officer directly for any clarification/relaxation for Model Code of Conduct. If any relaxation is required the necessary proposal shall be submitted through their Administrative Department of Secretariat with clear request on which instruction of the Election Commission of India relaxation is required, full justification for such relaxation and necessary recommendation of the Administrative Department.
