Attention is invited to the references cited and it is informed that in this office Memo. 3rd cited, the Superintending Engineer, Irrigation Circle, Sangareddy was informed that the local candidature shall be monitored while filling up the posts under direct recruitment. In case of medical invalidation as per para 17 of G.O. No.661, dt.23.10.2008, the compassionate appointment on medical invalidation shall be limited to 5% of direct recruitment vacancies in a unit.

In the reference 4th cited, the Chief Engineer (Irrigation), Sangareddy was stated that there is an ambiguity arose whether 5% of Direct Recruitment vacancies is to be worked out on total strength of posts or on total No. of vacancies in that category or total No. of direct recruitment vacancies. He has sought clarification to kindly guide in the matter and issue the suitable instructions.

As per Para 17 of G.O.No.661, GAD, dated 23.10.2008, the compassionate appointments on medical invalidation shall be limited to 5% of Direct Recruitment vacancies in a unit of appointment.

Further, Government in Memo.No.11601/Ser.I(2)/2016-2, dated 28.02.2017 has clarified that the compassionate appointments on medical invalidation shall be limited to 5% of Direct Recruitment vacancies in a unit of appointment as per Para 17 of G.O.No.661, dt.23.10.2008. Hence no appointment can be beyond the prescribed quota and no appointment shall be made in other units of appointments as per the said G.O.

The details of CE(I), Sangareddy unit, are submitted as under.
