The Government vide above said Memo have clarified that, as per the consolidated guidelines on the scheme of compassionate appointments issued vide Government Memo No.60681/Ser.A/2003-1, G.A. (Sr.A) Deptt., Dt.12-08-2003, the maximum age limit for compassionate appointment was 33 years as per rule 12(1)(a)(v) of General rules. Subsequently, the same was enhanced to 34 years and said rule was amended vide G.O.Ms.No.759 GA (Ser.D), Dt.06-10-2007. Hence, the maximum age limit for compassionate appointment is to be taken as 34 years.

Hence, all the Engineer-in -chiefs, Chief Engineers are requested to follow the above rule position scrupulously while issuing compassionate appointments in their units.


