With reference to the letter cited, the Engineer-in-Chief (Irrigation) Ramagundam is hereby informed to take necessary action as per rules in force and follow the instruction issued in G.O.Ms.No.5 (SW.ROR.1)Dept, dt. 14.02.2003 read with G.O.Ms.No.2 (SW.ROR.1)Deptt., dt. 09.01.2004, regarding carry forward of vacancies as referred in G.O.2nd cited above.

In case, qualified candidates of SC/STs are not available, for a particular panel year, the vacancy shall carried forward to the subsequent year. In the Second year, if SC/STs are not available the vacancies or points meant for SC/ST candidates may be filled up by candidates from the feeder category based on merit and seniority. The number of such vacancies meant for SC/ST should be carried forwarded and filled up in the immediate subsequent year with SC/ST candidates.

Therefore, the Engineer-in-Chief (Irrigation) Ramagundam, is requested fill up Roster point No.6 meant for Visual Handicapped (V.H) duly following the guidelines issued in the above G.Os. and directed to take necessary action as per rules in force.
