It is submitted that after bifurcation of the State the TSIDC is functioning wef 2.6.2014. The Govt., is giving utmost priority to Irrigation sector and has entrusted a huge task of executing of Lift Irrigation Schemes and insisting to complete the schemes as per the target fixed to TSIDC. In order to achieve the target fixed by the Govt, and in order to cope up with the work load and utilize the working season the services of the AEE/AEs are essentially required in the Corporation.
