Irrigation &CAD Department – Formation of New Districts –Reorganization of Minor & Medium Irrigation Sector of **Nizamabad and Kamareddy** under Irrigation Circle, Nizamabad – Orders-Issued-Regarding

The Government of Telangana have issued orders for formation/ reorganization of Districts, Revenue Divisions and Mandals in the State of Telangana, vide reference 1st cited for better administration and development of the areas comprised therein. As per the orders, new districts have been formed in the state of Telangana on 11.10.2016.

Due to formation of the new districts, the present jurisdiction of some of the Executive Engineers of Minor & Medium irrigation falls in two to three districts. Since the Executive Engineers have been designated as the District Irrigation Officers vide reference 2nd cited by the Government to coordinate with district administration for the Minor and Medium Irrigation activities in the district, it is proposed to revise the jurisdiction of the Executive Engineers of Minor Irrigation so that entire jurisdiction of One division shall fall within the district only.

Accordingly, proposals were submitted to the Government. The Government vide reference 3rd cit ed reorganized the Minor & Medium sector Irrigation with revised staffing Pattern and permission for attachment and detachment of Sub-Divisions. Further, the Government have accorded permission to redeploy staff within sanctioned strength and effect transfers as per his competency strictly in conformity with the presidential orders.

In view of the above, the reorganization orders are hereby issued in respect of Irrigation Circle Nizamabad as detailed below.

Nizamabad District

I.B. Division Nizamabad with 3 Sub- Divisions.

The existing IB Division Nizamabad consists of 4 Sub Divisions. Two Sub Divisions are detached from this division and one new Sub Division is attached to this division, thereby, the division is ordered to function with 3 Sub Divisions only.

a) The existing O&M Sub Division, LI Scheme, Nizamabad and IB Sub Division Armur of IB Division Nizamabad are detached from IB Division Nizamabad and attached to Projects Division Bodhan. b) The existing IB Sub Division Bodhan of IB Division Bodhan is now detached from IB Division Bodhan and attached to IB Division Nizamabad and ordered to work under the control of IB Division Nizamabad with same headquarters.

Kamareddy District

I.B. Division Kamareddy with 3 Sub- Divisions.

The existing IB Division Kamareddy consists of 2 Sub Divisions. There is no change in the existing set up of this division. One Sub Division is attached to this division, thereby, the division is ordered to function with 3 Sub Divisions.

a) The existing IB Sub Division Banswada of IB Division Bodhan is now detached from the IB Division Bodhan and attached to IB Division Kamareddy with same head quarters and ordered to work under the control of IB Division Kamareddy.

Projects Division, Bodhan with 4 Sub- Divisions.

The existing IB Division Bodhan consists of 3 Sub Divisions and presently looking after the works of Minor and Medium Irrigation. Now IB Division Bhodhan is renamed as Project Division, Bodhan with same headquarters duly entrusting Medium Irrigation Projects and Nizamsagar Project activities to this Division.

Two Sub Divisions are detached from this division and additional 3 Sub Divisions are attached to this division as detailed below, thereby the division is ordered to function with 4 Sub Divisions.

- a) The existing IB Sub Division Banswada of IB Division Bodhan is detached from IB Division Bodhan and attached to IB Division Kamareddy of Kamareddy District.
- b) The existing IB Sub Division Bodhan of IB Division Bodhan is detached from IB Division, Bodhan and attached to IB Division Nizamabad of Nizamabad District
- a) IB Sub Division Jukkal HQ: Nizamsagar is now renamed as Project Sub Division, Nizamsagar with same headquarters.
- b) O&M Sub Division, LI Scheme, Nizamabad of IB Division Nizamabad is now detached from I.B. Division Nizamabad, and attached to Project Division Bodhan, duly renaming as Project Sub Division, Nizamabad with same headquarters and ordered to work under the control of Project Division, Bodhan.
- c) IB Sub Division Armur of IB Division Nizamabad is now detached from I.B. Division Nizamabad, and attached to Project Division, Bodhan duly renaming as Project Sub Division Armur with same headquarters and ordered to work under the control of Project Division, Bodhan.

d) A new Project Sub Division is formed as Project Sub Division Bhanswada, duly diverting one post of Deputy Executive Engineer from O/o the CE, NSP, Hill Colony.

Sri Dattatri, Deputy Executive Engineer, Project Sub Division Nizamsagar is directed to form Project Sub Division Banswada and hold full additional charge of the post until further orders.

The Statement showing the reorganization structure of Minor & Medium Irrigation Sector in respect of Nizamabad and Kamareddy Districts under Irrigation Circle, Nizamabad, in which Sub Division wise Jurisdiction, Mandals covered and number of sections in each sub division are shown, is herewith appended.

The relevant records of works shall be handed over to the concerned, as per the reorganization ordered above at Section/Sub Division level/Divisional level as applicable.

All the staff working in the Divisions/Sub-Divisions shall move along with Divisions/ Sub-division as ordered above, unless specific transfer orders are issued.

The Circle Scale Establishment working in the Sub Divisions now shifted or detached from the existing Division shall report to the respective Division office under whom presently working for further postings.

The Lien and seniority of circle scale establishment will be continued to be maintained at existing parent circle only.

The statement showing division wise existing sanctioned strength and sanctioned strength accorded after re-organization of Irrigation circle, Nizamabad is herewith enclosed as Annexure-1.

In view of the reorganization ordered above, transfers of few individuals in different cadre are effected as indicated in the **Annexure-2** appended to this order. The Superintending Engineer is requested to arrange to relieve all the individuals now transferred immediately with a direction to join in the new station now posted.

The Superintending Engineer is directed to fix up the section headquarters of all Assistant Executive Engineers/Assistant Engineers duly considering the posting orders now issued.

These orders are placed in the department official website www.irrigation.telangana.gov.in. The Superintending Engineer is requested to download the proceedings from the website and take necessary action immediately.
